**Registration:** Registrants are accepted on a 'first come, first served basis'. Class size is limited, so you are encouraged to register early. Registration will not be accepted until received with payment in full together with all required information. Complete the registration form in its entirety. Legibly print or type and provide authorizing and acknowledging signatures, where indicated.

**Payment:** Rates are subject to change without notice. Payment, in full, is required at time of registration. AESYS accepts only \$USD Transactions. If a Company Purchase Order is issued, and payment is predicated on AESYS invoicing pursuant to Purchase Order, registration acceptance will not be in effect until payment in full is received. AESYS Invoicing Terms are Net 10 Days. AESYS accepts Company or Bank Check – Payable to: AESYS Technologies, LLC, or MasterCard / VISA / AMEX Credit Card Information, accompanied by completed registration form. Please note that all billings are immediate, and upon acceptance, will be applied towards the selected Program Date.

**Financial Assistance:** AESYS does not provide, or make arrangements for any special financial aid assistance to participate in this Program. There are however, federal, state and municipal sources of financial aid for continuing education.
